#### SPEAKER:

As part of a program to make people aware of a new data base (Clemis) being set up by the local police departments, Commander Jeffrey King of the Farmington Hills Police Department, spoke at the meeting. The purpose of the data base is to help vulnerable individuals in the community receive the most appropriate treatment when help is requested or required.

#### **COMMITTEE REPORTS:**

# Communications, Promotions, Website:

- Forms for evaluating senior homes and residences are not on website yet.
- It was suggested that dates for Law Day be published: May 2 and May 22.

# **Education:**

- Day time presentation on housing for seniors and how to finance them has been cancelled.
- An evening program, "Wise Ways to Choose Housing for Your Senior Years" will be presented in the fall, 2019. This program will discuss new options and market driven terminology. It will be presented by COA members and advertised in the fall activities book.

#### Community for a Lifetime:

- D. Fantore attended an open house for repurposing Harrison High and discussed a walking track.
- People who attended this open house were asked to choose 5 activities they felt were valuable. Written comments were also requested.
- C. Christoph who, in addition to the COA, is a member of the Commission on Parks and Recreation also attended the open house and was quoted in the Farmington Observer. He was impressed by the interest and enthusiasm for the project.
- K.Marshall reported that she had contacted Dan Dean, an editor of the Farmington Observer, many times about articles on aging but has been unsuccessful in getting any published.
- McCowan shared information that her sub-committee continues to be interested in the financial
  exploitation of seniors, and she hopes to establish specialized Oakland County court officials to
  handle these cases. Changes in the Oakland County Advisory Council have caused some delay.
  She also reported that the Oakland County Law Association is providing legal assistance to any
  person who has experienced credit problems due to the government shut down. She will be
  taking part in two Law Days in May.

#### Volunteer Recognition:

- The volunteer recognition breakfast will be held at 9am on April 4. COA members are invited.

- Meals on Wheels is limiting deliveries during frigid weather. Emergencies are covered.

## Members' Comments:

- C. Irwin distributed information about programs being presented by Botsford-Beaumont. She also said all support groups at Botsford -Beaumont are being discontinued.
- K. Marshall stated that the Geriatric Psychiatric Unit (Gero-psych) at Botsford-Beaumont will
  close in 2020. A new hospital will be built in partnership with U.H.S. in Dearborn, providing
  mental health services for those in the metropolitan area.
- C. Christoph who has been on the COA since 1988 shared this: Current members of the COA are a diverse, dedicated and enthusiastic group. They have undertaken worthwhile projects and worked hard make the area attractive to Farmington area older adults.
