COMMITTEE REPORTS:

COMMUNICATIONS, PROMOTIONS AND WEBSITE:

- Schulte reported the website has been updated with current information. There are no statistics on usage for this month. Koet suggested that Laura Champagne be removed from the member list, officers be updated and the title alternate be removed from Weglarz.

EDUCATION COMMITTEE:

- McCowan attended training regarding financial abuse of elderly people on March 17 and 18. She can now offer classes to interested people such as police officers, financial consultants, caregivers, and senior center employees. A sub-committee composed of Fantore, Irvin, Koet and Weglarz will help with the planning and implementation of a class which tentatively will be held in September, 2021. A grant from the Department of Justice will cover the costs of the program.

CITY COUNCIL REPORTS:

- Frost has not contacted Koet regarding this year's presentations.

SENIOR LAISON REPORT:

- Several city staff members are moving out of the Costick Center and into the HAWK. This will give much needed space to the Senior Division.
- Eleven Mile between Middlebelt and Inkster is scheduled for road repair. Watch for information.
- The tax preparers are working with 110 clients this year.
- Friday films resume in May. There will be no meal or treats offered.
- Red Hatters meet in April for a business meeting and then travel to a restaurant for lunch.
- Gift Shop is open on Monday and Wednesday mornings.
- Support groups, exercise classes and the pool are open,
- Meals on Wheels services 230 each day. Pick up meals number 30 each day.
- 80 Easter baskets will go to seniors this year.
- Discussion on resuming in person COA meetings was held. April meeting will be held at the Costick Center. Masks must be worn. Those who cannot attend or prefer not to be present will be able to access the meeting through phones.
