### Committee Reports:

#### Communications, Promotions and Website:

Schulte reported that she spoke with the webmaster, Geri Furi, who supplied the figures for number of contacts on the website. The numbers are down, and he suggested that new material would attract more viewers. Some discussion of what to add: press release of project on Exploitation of the Elderly, scheduled activities at the Senior Center, updated version of the Adult Resource Directory. Members were given a copy of the press release for review.

#### Education:

Fantore and McCowan discussed the committee's current focus: Exploitation of the Elderly. A slide presentation will be presented to the COA at the June 28<sup>th</sup> meeting. Frost has been helping with slides, handouts and reports to the city councils. It was decided that a handout would be given at any presentation and an email power point sent to those who request it. The handout would enumerate common financial exploitation problems and give specific places where help could be obtained.

#### Senior Division Report:

Koet shared the following information:

- Drop off for shredding services will be held on June 14 (10am-noon) limit is 4 bags
- Blueberry cookies will be sold at Art on the Grand June 4 and 5. COA members volunteered to help.
- Ice Cream Social is July 20.
- A grant for continuing Meals on Wheels is being submitted. Schulte will compose a letter of recommendation.
- Dine and Discover will feature the history of Longacre House.
- AAA1B is working against financial abuse of the elderly.

The evaluation of Farmington Hills facilities has shown that the Senior Center is meeting many home and community service needs. Regardless of the results of the study it is imperative that Meals on Wheels, transportation services and socialization activities continue in the Farmington-Farmington Hills area where the senior population continues to increase.

#### Old/New Business:

The newly appointed alternate from Farmington, Mic Fahey, was welcomed by the Commission. In response to his questions regarding what the commission has done in the past, a spirited discussion followed. It is encouraging to hear all that has been and continues to be done by this commission.
