COMMITTEE REPORTS:

COMMUNICATIONS, PROMOTIONS AND WEBSITE:

There are no confirmed numbers of visitors to the website for the past month. Once the completed slide show from the Education committee is available, it will be added to the website.

EDUCATION:

This committee is working on a short 21 slide presentation and a longer version concerning the Financial Exploitation of the Elderly.

This committee is meeting on November 30 and hopes to schedule presentations in January, 2023.

Marsha plans to have her staff view the presentation and will mention it at the interfaith meeting with a hope that churches may be interested.

CITY COUNCIL:

Presentations will be scheduled for late April and early May. Frost will assist Christoph.

SENIOR DIVISION:

Koet reported that scheduling at the Costick Center is returning to pre-pandemic levels.

Beginning January 3, 2023, AAA1B will only fund congregate meals that are eaten at the Costick Center. Carry outs will no longer be available. The reason for congregate meals is to encourage socialization among seniors and this is not promoted when seniors take food to their homes. It will still be necessary to order meals a day in advance for planning purposes. Meals will be served 12:00 to 12:30.

Income tax services will be available. Appointments can be made from February 3, 2023 until April 11, 2023. Appointments will be in person and available on Tuesdays and Fridays. 25 appointments per day will be arranged.

Adopt a Senior for Christmas continues.

Medicare Part D appointments are completed. The Bridge Group has returned.
