- Regularly scheduled activities at the center are down in size. Exercise classes continue.
- Adopt a Senior for Christmas is co ordinating with Goodfellows. About 500 will receive gifts.

# **OLD BUSINESS: AND NEW BUSINESS:**

• Fantore suggested that nominations for new offices be suspended and that present officers would keep their positions. All present officers agreed.

### AMBASSADOR REPORTS:

- Parks and Rec: Christoph reported on the expansion of the Arts program due to increased space at the Hawk. Blackthorne is scheduled for March 3 and am Elton John tribute about 2 weeks later.
- Michael Bridges, Farmington Hills city council liaison, stated that the council appreciates the work done by the COA. He expressed interest in the financial exploitation of seniors and offered services of the city to the COA.
- He also reported that the many power outages in the Farmington area are caused by DTE's failure to do necessary tree trimming. It is estimated the \$70 million dollars will be needed to resolve the issues.
- Problems with Spectrum have been intermittent. Sci Fi broadband will be available in about 2 years and should solve this problem.
- The Deer population is seen as a regional problem which will be solved by the region and not the City of Farmington Hills.
