E-Mail from Representative Christine Greig with responses to discussion and questions raised during May COA meeting.

Dear members of the Commission on Aging,

Thank you for hosting me at your May meeting. I wanted to follow up with you regarding some specific questions that were asked.

With regard to tax revenues, they steadily increased from \$18.5 billion in Fiscal Year (FY) 2010 to \$20.8 billion in FY 2013 and dropped very slightly to \$20.5 billion in FY 2014. The projections for FY 2015 have them up again to \$21.4 billion.

With regard to heavy trucks crossing state lines, in general, heavier Michigan trucks are allowed to use other states' roads if they purchase a special permit. They don't necessarily get to use all the roads in that state, but Michigan has agreements with other states to let heavy trucks access important areas such as the Port of Toledo in Ohio or the steel mills in Gary, Indiana.

The Medicaid Waiver and Meals on Wheels both received a funding boost in FY 2014. Care for seniors was one of my top priorities during this year's budget debates and I would have liked to see funding for both these programs expanded once again. However, funding for both programs was held at current levels in this year's budget.

Michigan's Tourism Industry is flourishing thanks to the most freshwater coastline in the United States, the 5th best craft beer industry in the country, and the nation's number 1 ranked state park system according to the National Recreation and Park Association. Michigan is a drive-to, as opposed to a drive-through, destination. The recession hit the tourism industry particularly hard, costing Michigan about 60,000 jobs. But thanks to improvements in the states economy and great programs like Pure Michigan, employment in the tourism industry is back to pre-recession levels and continues to grow. However, the Republican's roads plan that recently passed the House cuts funding to Pure Michigan, something I think we can't afford to do with the industry in the middle of a growth spurt.
