CHARTER TOWNSHIP OF PLYMOUTH
REQUEST FOR PROPOSALS FOR MUNICIPAL LEGAL SERVICES
The Charter Township of Plymouth is requesting proposals from legal professionals able to provide a variety of legal services required by the Township as Township Attorney and to assist the Township Board of Trustees, Supervisor and Municipal operating departments as required. The legal services desired include but are not limited to:
A. Legal counsel in the form of attendance at meetings of the Township Board of Trustees, Planning Commission, Zoning Board of Appeals, Act 78 Civil Service and any other board or commissions as may be desired.
B. The drafting of legal letters of opinion, interpretation of administrative codes, state statutes, ordinances, federal and state regulations and policies.
C. The drafting of municipal ordinances involving all matters related to municipal corporation operations.
D. Legal review of codes, contracts, statutes and proposed resolutions of the Township Board of Trustees.
E. District Court litigation involving the prosecution of municipal ordinance and code violations.
F. Such other duties as may be prescribed by Ordinance or by direction of the Township Board of Trustees and/or Supervisor.
The Township is seeking the proposals for professional legal services to compare the quality of level of service for the purpose of selection of a Township Attorney and Associates as may be proposed, to provide legal services to the Township for the next year with options to extend for additional years. The initial contract period shall commence June 1, 1993, until June 1, 1994.
