Committee chief named

Rolland Wilkening of Farmington Hills, president of Barton-Malow Company, has been named chairman of the Construction Management Committee of the Associated General Contractors (AGC) of America, an industry organization which represents 8,232 companies nationwide. A member of the committee since its inception, he is co-author of "Construction Management for the General Contractor," a book published by the AGC, and has made many appearances at construction management seminars and professional conferences.

Wilkening has been a leader in the development of the construction management method as a means of increasing efficiency and reducing costs in major construction projects. Barton-Malow's completion of the Pontiac Silverdome "on time and within budget" has been widely cited as an example of the advantages obtained through application of advanced construction management techniques.

Couple sues Dr. Krohn

A West Bloomfield Township couple has filed a civil suit in Oakland County Circuit Court seeking damages against a doctor who they charge assaulted the wife.

Santoro and Ann Mae Porvin filed the suit Thursday against Dr. Donald R. Krohn of Farmington Hills.

In a criminal suit resulting from the alleged assault on Mrs. Porvin last October in her home, Krohn was found not guilty of second degree criminal sexual conduct by reason of intoxication.

The Porvin's suit is for \$1.1 million, including \$1 million for alleged mental and physical injuries to the wife. Her husband is suing for \$100,000 for loss of consortium.

The case will be heard by Judge Stephen N. Andrews. No hearing date has been set.

Charges are still pending against Krohn, who is head of obstetrics and gynecology at Southfield's Providence Hospital, for driving under the influence of alcohol.

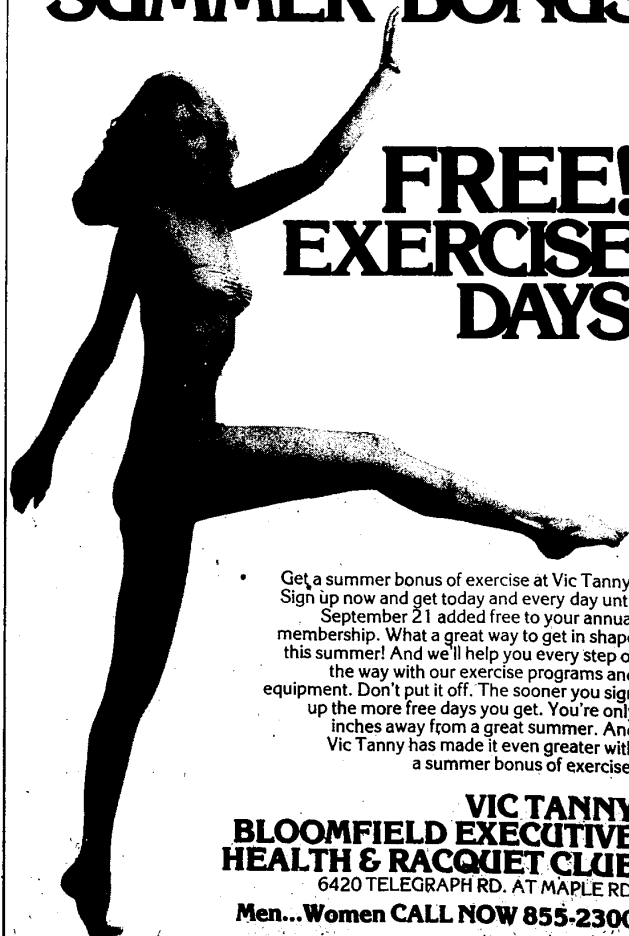
