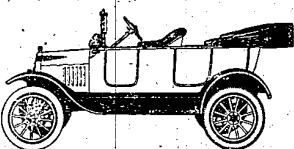

WANTS TO BE CIRCUIT JUDGE
Judge Kleber P. Rockwell of the Probate Court has announced his candidacy in another column for the nomination at the March primary on the Republican ticket for the office of Oakland County's Circuit Judge.

Judge Rockwell was elected Judge of Probate last fall for the third term, leading his ticket by a large majority, and seems to have given universal satisfaction in that capacity, as he has in a number of other responsible positions in the past.

He was born in Bloomfield township on November 8, 1868. His boyhood was spent on the farm; later teaching school for a number of years, when he took up the study of law, and was admitted to the bar in 1896. In November, 1898, he was elected Prosecuting Attorney of Oakland county, in which capacity he served for three terms, declining the fourth.

He served as a member of the state constitutional convention in 1907-8, having received the support of both Republicans and Democrats of the Twelfth Senatorial District, in the nomination and election to that position, where he served on the judiciary and public utilities committees.

Judge Rockwell is a member of the State Probate Judges association, having served as its president; is a member of the Michigan State Bar association, and was a law partner of Hon. H. M. Zimmerman up to the time of his election as Probate Judge in 1908; a member of the K. of P. B. P. O. E., the First Congregational church of Pontiac, a staunch Republican, and a general all-around good fellow.

A Kansas editor seems to have gotten an inspiration on the war situation and it is apparently clear (?) to him that he has given his explanations as follows: "The Allies left is trying to move around the German's right, but the German's right is also moving around the Allies' left. Large numbers of automobiles passed through town last week, one day 45 Fords in a string were counted going west. Many of the manufacturers of cars are sending them out over the country in this way, on account of the shortage of freight cars. The Oakland company of Pontiac is reported to have started a string of 90 drivers with cars to be delivered in Pennsylvania, Ohio and Indiana last week.

During December there were reported 3,373 deaths in Michigan, and 6,968 births. Twelve deaths are credited to the Pontiac State Hospital. The greatest death rate is reported from Luck county, and the greatest birth rate from Wayne county.

At the opening of the Birmingham schools [Monday] 150 pupils were sent home because they had not been vaccinated, and cannot return until three weeks after the last smallpox quarantine has been lifted.

Northville's new school building will be finished in two weeks. It is up-to-date in every respect.

Lewis Haack fell 50 feet from the top of a windmill at his home near Birmingham Monday, breaking his right leg near the hip; also his right ankle and elbow. He also suffered internal injury. He is 56 years of age.

Sheriff Green warns residents of the county to look out for a man canvassing the country for an automobile accessories profit sharing scheme, in which he collects \$15 for a certificate that purports to allow special discounts.

The Republican county convention has been called to meet in Pontiac February 14th, to elect 33 delegates to the state convention in Detroit February 20th. Farmington is entitled to three delegates to the county convention, Novi two and Southfield two.

In order to collect \$16,103.48 from the village of Birmingham, a balance due on a paving contract, an Ohio firm was obliged to bring suit, although the village was agreeable to the payment. The village is bonded to the limit, and the only way the money to pay the indebtedness could be raised was by a court decree, compelling the corporation to pay its bill. The judgment was granted in favor of the paving company by Judge Smith.

Bethlehem's Bid on Shells for the United States Navy.

To the American People:

The Secretary of the Navy has awarded contracts amounting to over \$3,000,000 for a bridge bidder for 14-inch and 16-inch projectiles for the Navy because of very much lower prices offered by the English bidders.

We know nothing of the basis upon which the British bids were made, but the public is entitled to know the facts upon which we ourselves bid for this work.

Two years ago we took contracts to make 4,200 14-inch shells at a price of \$1,515,000. Up to now not a single shell has been accepted by the Government, although we have expended, in wages, materials, etc., on these orders \$222,881, and we have not received a SINGLE DOLLAR on these contracts.

In addition, a literal interpretation of the contract might make us liable for penalties according to \$94,000.

In the light of our experience, and having no other basis, we bid for 16-inch shells approximately the same rate per pound as that which the Navy Department actually awarded a 14-inch shell contract one year ago.
