

Dollars that Fight

By SENATOR HENRY CABOT LODGE

The war will be won by men and ships, by guns and airplanes. To raise armies and supply them, to build the navy and support it, and to furnish ships and transport, we must have money in large amounts. The expenditures of the Government for the ensuing year are estimated at \$24,000,000,000, a sum which baffles the imagination to conceive. That vast amount must

come one-third from taxes and two-thirds from loans. The success of the Fourth Loan, like those that preceded it is, therefore, absolutely necessary. We must work with the highest speed, as if the war was to end in six months. We must prepare in every direction, as if it was to last for years. Speed and preparation are both expensive.

Without the Loans we cannot have either

We are fighting to secure a just, righteous and lasting peace. For a complete peace we must have a complete victory. It must not be a peace of bargain or negotiation. No peace which satisfies Germany can ever satisfy us. No peace that leaves Germany in a position to renew the war against us will be worth having. It will be far from sufficient to gain all our objects on the Western front—Belgium, Alsace-Lorraine, Italia Irredenta. The President with wisdom and foresight and great force expressed his determination to redeem Russia. Russia

must not be left in Germany's hands. That would mean another war. Poland must be free. Slav republics must be established to bar the way between Germany and the East. Serbia and Roumania must be redeemed. All these things are essential. *Nothing will bring them but complete victory and a peace dictated by us and our allies.* It is a conflict of ideas. It is the principle of evil arrayed against the principle of good. It is the battle of freedom and civilization against barbarism and tyranny. *We must win and we shall win.*

WILL YOU HELP OUR BOYS ABROAD?

Every Man, Woman and Child Can Join to Send News of This Town Into the Front Line Trenches.

WHOLE NATION MOVES TO BANISH SOLITUDE

Our Heroes Are Calling From Over There—Give What You Can to Help Those From Home.

Every citizen interested in the boys of his home town now at the front, and in the brave women who equally are serving their country abroad, has an opportunity to show his appreciation of the services they are making. The opportunity comes as a result of the generosity and thought of Colonel William Boyce Thompson of New York, who has conceived and put into operation what is known as the Home Paper Service.

Under the plan, every man and woman in foreign service will receive a town newspaper, and so be kept in constant touch with the places and the people they know and love.

Every branch of the United States Government is interested in the plan. The Government realizes the importance of keeping those in the service happy and content in touch with their home ties and associations. Nothing is more depressing in a national emergency than the spirit of loneliness in those serving their country, and officials know that nothing can dispel this feeling more effectively than reading the home town newspaper.

Publishers of newspapers in all parts of the country—this newspaper included—have prised with pleasure the plan outlined by Colonel Thompson, and they have agreed to co-operate in every way.

Under the ruling of the War Industries Board newspaper publishers are forbidden to send their newspapers free, even to soldiers. The newspaper must be subscribed for in the regular way, the only exception being soldiers who formerly were in the employ of the newspaper and who left that service to enlist. Colonel Thompson therefore proposes that the public in each community contribute to a fund so that the home newspaper (in our case this newspaper) may reach every man and woman now in the service of his country.

Anyone may contribute to the fund, and any sum may be contributed. It is not necessary to contribute the entire amount of one subscription. It does not matter whether the rich man sends in one hundred dollars for the poor boy or little girl sends in five cents. Each gift will be a message of love and helpfulness to the home town folks "Over There." The money will be lumped into one fund, out of which subscriptions will be entered as fast as the money is received.

Contributors who send in the full price of a year's subscription may, if they wish, designate to what particular person they wish the newspaper sent, but if the name given is already listed as receiving the paper, then the publisher reserves the right to apply the subscription to some less fortunate soldier boy or noble woman who is just as lonely for news of home and home folks.

The name of every contributor to this home paper service will be published in this newspaper, and the name of everyone entered for a subscription will be published as well as the number of those remaining whose subscriptions have not been covered.

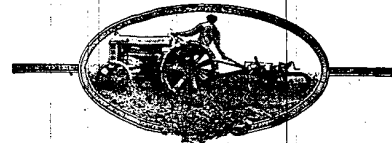
If the amount of money received shall be more than is necessary to send the paper to every person from the town now in the service, then the balance will be turned over to the Red Cross.

The plan is endorsed by the publisher of this newspaper without any thought of profit, either directly or indirectly, but with a sincere desire to help keep the home fires burning and to send to our heroes and heroines news of our town, to keep their hearts warm for us and to let them know they are constantly in our minds.

The publisher, of course, cannot make a profit on circulation, and additional circulation such as this will be circulated from non-purchasers sent far across the sea—can have no added value to the advertiser.

These facts are stated so that every contributor may feel that every cent contributed goes to the good cause.

The mothers of our boys are facing an ordeal with a heavy heart. Commands respect and admiration. Here and there they stars are turned from blue to gold, where anguish grips the heart, the nation stands in silence and honors the woman who have drop of their blood, the very bone of their bone, to their country. To them, time has lost its meaning—the soul of it has fled—there is no home. It is just a place, and no place is quite so lonely, unless it be within the hearts of those brave sons in far off France who long for just a word of home. There cannot be a man, there cannot be a woman, not even a child, who will fail to contribute just a little to make the hearts of these patriots lighter. Not one. Not in our town.

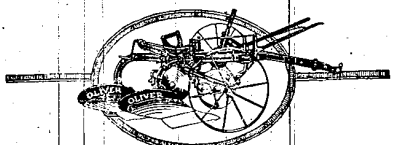

Eggs at \$1 a Dozen

Fresh eggs will sell for \$1 a dozen this winter, according to the present outlook. Although the number of eggs in storage and the number of pullets for egg production is normal in the cornbelt, the prices of feeds, labor, and other items of cost are so high that \$1 a dozen will not yield more than a fair profit. While eggs have been gradually increasing in price for some time, the profits to the producer are no greater than three years ago. At that we would rather live here in good old U. S. A. than in Europe, where most of the poultry has been killed.
