The scene is virtually the same—a boise with no fenced yard, a dog on the loose, and complaining neighbors watching from beind closed doors and windows—whether control officers are partolling Birriangham or Walled Lake, Bloomfield Hills or Commerce.

OFFICER DARRELL is one of 10 officers who patrol more than 800 square miles of Oakland County. On an average day, he will drive 100-165

miles. Much of his time, he said, is spent driving in and out of subdivisions to answer complaints friends and neighbors lodge against one another. Although the Oakland County Animal Control Center's primary responsibility is to prevent the spread of rables, Durrell said his main job is to pick up strays, cajole owners into buying licenses, and all to offen deliver the news that a lost animal has been killed by a car or truck. "It take more abuse in one day than 1 did in six months before I took this job," said the five-year veteran officer when schoolchildren gestured obscene messages as he passed. There is no sense getting mad at them, he said, because they are only imitating what been have learned from their parents. Officer Darrell believes that most people shouldn't be allowed to own pets. "He wanted to know if I expected them to let the dog soil their own lawn," he explained wearily as he climbed back behind the wheel.

"After a while, they all begin to sound alike," he said." Yes, we have a license. No, the tags are in a drawer someplace and I can't find them." "Technically. I can take the dog. But I usually give them a warning and hope that they lig eth elicense." At still another house, Darrell stood gingerly balancing his weight, hoping that the rotten floor would not give way beneath him. Again the license tags were missing, lost in the litter of fithy dishes and empty beer bottles.

Darrell asked two unkempt teenagers who would pay the fine if he

issued a citation. The two looked at one another for a moment then announced that their absent mother would.




