Doctors, lawyers square off

THE WHOLE MESS of malpractice suits could be avoided if doctors would just be more careful, Miller said. Doctors are blaming the "victims," and the "victim's lawyers," he said, when they should instead be looking to their own practices. According to statistics compiled by the physicians' committee, lawyers collect approximately 80 percent of each dollar spent on malpractice cases. But Miller said lawyers only get paid if the case is won, which isn't all that often.
