Farm Bureau Notes.

Farmers from Oakland, Monroe, Macomb, Washtenaw, Wayne and Genesee counties met in the Detroit Board of Commerce Friday to assist in forming the program of work for the new agricultural division of the board.

Oakland county was represented by Bert Holden, of Milford, President Oakland County farm bureau; R. J. Coryell, Birmingham, Secretary Oakland County farm bureau; Geo. Gunn, Rochester, Vice-President Oakland County farm bureau; E. J. VerDun, Novi, President Oakland County Horticultural Society; Harry Rackham, Northville and John Miller, Birmingham.

The principal subjects discussed were marketing of farm products from the surrounding counties in Detroit, ways and means for simplification of methods and the co-operation of city business in helping farmers obtain longer termed seasonal credits.

It was pointed out by C. A. Bingham, organizer of the state farm bureau, now in charge of the Board of Commerce agricultural division, that people in the city rapidly are coming to a realization that farmers have peculiar problems and the city folks through the agricultural division are ready to try to work out these problems.
