Michigan News Tersely Told

Port Huron—Charged with performing a criminal operation on a 16-year-old girl, Dr. Lucius G. Fitzgerald is under arrest.

Standish—Miss Laura Hublitz, attending high school here, had her nose broken in practicing basketball and Helen Bolt, another girl, received severe injuries to her head.

Marshall—While passing through the railroad yards Christmas morning, a train derailed and its engine, George Cooley, 62, dead, was killed by a freight train. He did not see the approaching train.

Manistee—Prosecuting Attorney R. F. Little has released Mrs. Mary R. Little for the murder of her husband, charged with killing her daughter's child. The mother of the child is held for trial on a charge of manslaughter.

Pontiac—Allen McKay, a former deputy sheriff, was convicted of selling a gallon of whiskey to Mrs. M. J. McKnight, who was charged with the charge of killing her daughter's child. The mother of the child is held for trial on a charge of manslaughter.

Clinton—Settlement for 12 sheep killed by his automobile when he drove Mrs. Steven Oleksiak into a grove, has been made by W. W. Reese, Detroit real estate dealer, for Dell Campbell and S. Tate, of Clinton.

Pontiac—Four small children followed Mrs. M. J. McKnight into court when they were arraigned on charges of selling liquor. Because of the size of the family, Judge Covert let Oleksiak off with 45 days in jail and released the mother on suspended sentence.

Grand Rapids—Declaring ice cream manufacturers have announced a willingness to decrease the wholesale price of their product Jan. 1, when the government tax is dropped, City Manager Fred H. Locke has asked all retail places to reduce their prices to a standard of 10 cents a dish.

Grand Rapids—United States District Judge John W. Peck of Cincinnati will begin hearing chancery cases in the federal court Tuesday.

Grand Rapids—A woman who was fired three shots over the heads of a crowd of inmates who had hurried to the spot where William Moore and William Kersey, both colored, were being hanged.

Kalamazoo—Albert Van Haften obtained divorce after he told Judge Welmer that his wife frequently locked the children out of the house while she went to questionable parties, and that on one occasion one of the children was contracted by pneumonia as a result. Custody of the children was given to the father.

Kalamazoo—Samuel Lavarack, of Comstock, is the first Kalamazoo man known to have been arrested on a charge of stealing back a gift that he had made to another. He was seized on complaint of Deputy Game Warden Frank Denner, who charged him with stealing the ferret he had turned over to the state a few days ago. The ferret is valued at \$10.

Albion—An old-fashioned runaway in which Paul Kreger, a cow, a calf, a team of horses and a farm-wagon figured, occurred in Albion when the horses, driven by Kreger, were frightened by a railway train. The team stopped when the wagon overturned. Kreger was thrown out and covered. The vehicle was badly damaged but both the cow and the calf which were in the wagon, escaped unhurt.

Fenton—The village council has purchased the Penton mill property of James Thomas, at a cost of \$5,200. The deal includes two 8-horse power turbine water wheels, which will be used to operate the water plant, doing away with the present steam system of operation. It is estimated to have done nothing, except to make an arrest after the mother of youth that escaped with Sullivan had informed the Ionia authorities exactly where Sullivan was to be found. The reward should go to the mother, he said, if it is not a lie.

Grand Rapids—Isaac Edward Bailey colored, said to be 105, died at his home here after a short illness. Bailey, born in slavery, escaped from Virginia several years before the Civil war, coming to Canada. He never moved to Grand Rapids, where he was married. He enlisted in what later became known as the "Lincoln cavalry," serving three years in the Civil war. At the close of the war he located in Grand Rapids. He was widowed several years ago. There are five children. He was said to be the oldest colored person in Michigan.

Flint—Charles M. Bogole, president of the Chevrolet Motor Co., died in Jacksonville, Fla., where he had gone with his son-in-law and his daughter, Mr. and Mrs. George W. Smith, of Flint, for a rest. He was 73 years old.

Muskegon—Charles Cribley, Ravena farmer, was intoxicated and did not want to go home to his wife and children. He went to the home of a neighbor and the next morning was found dead. Moonshine is believed to have caused his death.

Muskegon—If this city is to have a breakwater to improve the local harbor, it must share the expense with the United States government. Major F. S. Skinner, superintendent of the harbor, says a detailed report of the improvement has been postponed until Feb. 1.

Saginaw—John C. Williamson, aged about 45, and unmarried, who was injured in an auto accident during the summer, died at his home here last night. He was the uncle of William E. Williamson, who was killed in the hospital without regaining consciousness. Necropsy of the brain caused death.

Port Huron—The University of Michigan club of St. Clair county, at banquet in Marysville made plans to entertain President Marion L. Bushnell of the University of Michigan here next April, when he will attend the state conference of Parent-Teachers' associations.

Port Huron—Canadian officers directed Frank Blundell, also known as Frank Blundell, Ont. to J. W. Windsor, customs officers, sending him to Detroit. Blundell was accused of stealing \$20,000 worth of liquor from the residence of Customs Collector J. S. Spence.

Muskegon—Owners of bus lines voted off by the city of a special option, plan to continue operations, giving 60-cents free rides. City Attorney Farmer announces he will take court action to force the buses to discontinue. The people voted 4 to 1 against the bus.

Monroe—Many shanties are being hauled to Bolley's beach on Lake Erie, two miles south of here, for the fishing season. It is planned this winter to give a number of iceboat regattas along this lake shore. W. O. Sterling, of the committee of the La Plaisance Bay Ice Yacht club.

Lansing—Dr. R. M. Olin, state health commissioner, has been authorized by the state administrative board to appoint a consulting staff of four surgeons who will work with him in an effort to beat the statistics of some six or seven hundred child inmates of state institutions.

Saginaw—Frank Cosbit, janitor at the city hall, had a narrow escape from probable death when he was firing the flag in position and slipped on the icy roof. He would have fallen 125 ft. but for the eavesdropping which caught him. Policemen climbed the roof and rescued him with a rope.

Grand Rapids—Because Judge Orin S. Cross, of the Allegan circuit court, is president of the First National bank of that city, the case of the bank and other creditors of the F. D. Travis company has been transferred to the Kent circuit court. Judge John S. Mead has named Frank D. Blackford, of this city, receiver.

Kalamazoo—Fires of undetermined origin destroyed the \$13,000 home of George Irvine at Gull lake, a few hours after workmen had completed it. A hard coal fire had been kept in the furnace. The building was one story and was situated on a high bluff overlooking the water near the Gull Lake Country club. The loss was covered by insurance.

Lansing—The State Banking Department is calling attention to the fact that the failure of the C. W. Meridian Bank at Hartford has been taken up in newspapers as a state bank through error. Harry O. Mohrman, deputy banking commissioner, says the Hartford bank was not a state institution and that there were no failures of state banks in Michigan since 1913.

Iron Mountain—Sportsmen in this section of the upper peninsula have recommended to the state department of conservation of the bounty on wolves, also the retention of state wolf trappers to kill of the animals which have become a menace to farmers and sheep raisers in this section. They also ask that game wardens be chosen from a civil service list, to eliminate politics.

Lansing—Samuel Ford, former Marquette lifer, who recently was paroled by Governor Grosbeck, paid a personal call on the governor to express his thanks for his liberty and to plead for clemency for one or two other Marquette prison inmates, who were said to have been active with Ford in quelling the recent outbreak at Marquette. This plea will include Tom Leach and Rapier Barber, who held prisoners at bay while Ford summoned help. Leach is held for putting persons in fear with intent to rob a bank.

Grand Rapids—Federal officers here closed the salaried liberty Home owned by the late Dr. August Blewer. The beverage company's stock was seized. The action followed a statement last week by Judge A. J. Tuttle of Detroit, sitting on the United States District bench for Western Michigan, that he would suspend the sentence of 13 months in a federal penitentiary, imposed on Elmer A. Macdonald, for selling ingredients used in the manufacture of intoxicating beverages, unless similar places here were closed at once.
