CERTIFICATE OF TITLE
NEEDED.

Just a little over a month
remains before the certificate of
title law for automobiles goes in
to effect, and if anyone is think-
ing of selling their old car and
buying a new one, or if they are
just going to sell the old "boat"
they should be sure that they own
it, and should secure a certificate
of title from the state department
at Lansing or from one of the
numerous agencies that are scat-
tered about the state. A certifi-
cate of title, while showing the
present ownership of the automob-
ile, also shows the various own-
ers of the car before it came to the
present ownership, if there were
such owners, and is a positive
guaranty of the ownership. Ac-
cording to the law one must have
a certificate of title by July 1, to
be the legal owner of the automob-
ile that he or she has. Such a
certificate is certain to eliminate
the troubles that will probably
confront those who attempt to sell
a car if they do not have the certifi-
cate.

Bankers, garage owners and
others interested in the sale of
automobiles are urging that their
friends procure the needed certifi-
cates of title before July 1, and to
secure them at the earliest possi-
ble date, as there is certain to
be a rush for the certificates to-
ward the latter part of June.

Applications may be procured
from any of the numerous agen-
cies, one of which is located in
Lansing. The certificates con-
tain blanks which are filled out
with the name of the owner, ad-
dress, complete description of the
vehicle and engine and the serial
number. It also shows how and
when the automobile was pur-
chased.

The loss of a certificate, or failure
to procure one will result
much the same as would the loss
of a deed and abstract to a piece
of property.

M. A. C. Tests Show
Relative Feed Value.

That corn is the best all round
grain for fattening hogs, while
normal silage is superior to stover
silage for best feeding, is shown
by the results of extensive feeding
tests carried out at the Michigan
Agricultural college during the
past few months.

Results of the experimental
work, which was completed on
May 6, were announced at a
Feeders' Day meeting held at the
college recently. This was the
second year on the same tests, a
third being planned before defi-
nite results can be given out by the
college specialists.

Three lots of steers were on
test in the experiment, the first
being fed normal corn silage, sup-
plemented by linseed meal and
clover hay; the second, stover
silage, linseed meal and clover
hay; and the third the same ration
as the second, with the addition
of an amount of shelled corn
equal to that which was taken
from the stover silage when it was
ensiled. Some shelled corn was
added to the rations of all lots.

The first lot, on normal silage,
made the most effective gains, as
was the case in the 1921 experi-
ment. The three lots, when sold
at the Detroit yards the middle of
May, brought an average of about
\$3.25 a hundredweight. Six of
the seven animals in the first lot
brought \$8.35.

Tests run with hogs during the
same period to determine the rel-
ative value of various home grown
grains for high fattening work,
brought out the fact that corn
ranks first as a hog grain feed.

Returns on the hogs fed corn
and tankage showed \$1.10 a bush-
el for the corn, with hogs selling
at nine dollars a hundred.

Hear Pleas of 65 for Citizenship.

Hearings on 65 petitions for
citizenship in the United States
have been scheduled for hearing
before a special examiner and
Judge Glenn C. Gillespie on June
5 in circuit court. Notices are being
sent out to the applicants by the
county clerk. This is a week
prior to the opening of the June
term of circuit court but the date
was fixed by the naturalization
department.

LEGION TO CARE
FOR VET'S ORPHANS

Cottage Group Planned Where Chil-
dren May Find a Home.

Detroit—Tentative plans for a chil-
dren's colony in Michigan where the
American Legion will care for or-
phans of men killed in the war or
who died of injuries as well as chil-
dren from homes of war veterans who
have become destitute, have been
formulated by state officers of the
Legion.

Under the present plan the colony,
said to set a precedent in American
Legion activities will be in operation
within a year.

The plan has been adopted as an
ideal program by the national Legion
organization.

Six Michigan communities already
have offered free sites to the colony,
and have pointed out the advantages
of their respective locations.

An effort will be made to obtain
land near a lake in order that the
children cared for will have diversi-
fied recreational advantages.

The children will live in semi-mod-
ern cottages of several rooms each,
between six and nine youngsters be-
ing assigned to each home. A cottage
mother, probably the widow of some
war veteran, is to be placed in charge
of each cottage. She will receive shel-
ter, food and clothing as recompense
for becoming the "mother" of the
children.

As conceived by Paul Martin, Battle
Creek newspaper man and state com-
mander of the Legion, the plan pro-
vides for making each cottage a mem-
orial to some dead war veteran, the
homes being provided by relatives of
the victims as memorials to them.

John G. Emery, former national
commander of the Legion, is to serve
on the committee to choose a site for
the colony.


Richard Peckham was a veteran of

ten dollars for it."


Richard had missed that meeting.
