

House limits congressional checks on CIA

Here's how area members of Congress were recorded on major roll call votes May 22-23.

HOUSE

CIA OVERSIGHT: By a vote of 325-50, the House refused to continue the requirement that the Central Intelligence Agency report covert operations to eight House and Senate committees either before or after the mission. Left standing by the vote is a softening of the CIA's obligation to tell Congress about its work.

The new language says the CIA must report only to the intelligence committee in each chamber; the report must come in advance of the mission, except in "extraordinary" circumstances. The vote came during debate on a foreign aid bill later passed and sent to the Senate.

Rep. Ted Weiss, D-N.Y., who voted "yea," said U.S. Intelligence agencies committed "terrible abuses" in the past and that it would be "a major step backward" to lessen congressional checks on the CIA.

Rep. Clement Zablocki, D-Wisc., who voted "no," said: "If we are to have an effective foreign intelligence capability... we must take steps to reduce the likelihood of leaks to an absolute minimum."

Members voting "nay" wanted to make the CIA more independent of the Congress.

Rep. David Bonior, D-Mt. Clemens, voted "yea."

Reps. William Ford, D-Taylor, William Brodhead, D-Detroit, James Blanchard, D-Pleasant, and William Broomfield, R-Birmingham, voted "nay."

Rep. Carl Pursell, R-Plymouth, did not vote.

AID TO NICARAGUA: The House adopted, 267-105, an amendment eliminating about \$5.5 million in military aid slated for Nicaragua. The money was cut from a fiscal 1981 foreign aid bill.

Rep. Robert Bauman, R-Md., the sponsor, said: "The government of Nicaragua today is controlled by Communists, working closely with the Soviet Union... (and) with Castro's government."

Opponents said Nicaragua's fealty to communism

is not absolute, and that U.S. interests are harmed by severing ties with the Sandinista government.

"Why do we not try to work with them?" asked Rep. Peter Peyser, D-N.Y.

Members voting "yea" wanted Nicaragua to get no fiscal 1981 military foreign aid.

Sawyer and Broomfield voted "yea."

Bonior, Ford, Brodhead and Blanchard voted "nay."

Pursell did not vote.

SENATE

CIVIL RIGHTS FUNDS: By a vote of 76-14, the Senate killed an attempt to cut the fiscal 1981 budget for the U.S. Commission on Civil Rights from \$11.7 million to \$6 million. The commission is an independent government agency established in 1957 to study civil rights problems and make recommendations. The amendment was offered to S2511, later passed and sent to the House.

Sen. Birch Bayh, D-Ind., who favored preventing the budget cut, said it would be wrong for the Senate to "go on record as being against the progress that has been made to assure first-class citizenship for all our citizens."

Sen. Jesse Helms, R-N.C., said: "Here we have a bureaucratic agency which, if it ever had any useful purpose, has long since discharged it."

Senators voting "yea" opposed the cut in the Civil Rights Commission budget.

Democrats Donald Riegle and Carl Levin voted "yea."

CIVIL RIGHTS LOBBYING: The Senate killed, 64-29, an amendment to cut the 1981 budget of the U.S. Commission on Civil Rights by 10 percent if the agency lobbied for or against legislation before Congress or state legislatures.

Sen. Birch Bayh, D-Ind., who favored killing the amendment, said charges that the Civil Rights Commission engages in political activity are "undocumented."

Sen. Jesse Helms, R-N.C., who supposed killing the amendment, said: "It borders on the unconscionable that the Civil Rights Commission, using an undesired aura of nobility, should be using the taxpayers' dollars" for lobbying.

Senators voting "nay" favored the penalty for any lobbying.

Riegle and Levin voted "yea."

HELPING SMALL BUSINESS: By a vote of 63-22, the Senate refused to kill an amendment calling for greater private sector involvement in a new government program to aid small businesses. The vote came during debate on a Small Business Administration bill, later passed and sent to the House. At issue was a network of "small business develop-

ment centers" to be established at universities with federal funds. The vote means that the centers will rely less on in-house staffs and more on consultants in the private sector.

Sen. Gaylord Nelson, D-Wisc., a supporter of killing the amendment, said the centers should be "managed and operated by a full-time staff which has had practical business experience."

Sen. Richard Schweiker, R-Pa., an opponent, said the private sector is best equipped to help the pri-

private sector, and called it "ironic that we start another government program and immediately turn around and build an in-house staff which, in essence, begins to become a bureaucracy in itself."

Senators voting "nay" wanted the centers to be operated largely by private sector personnel acting as consultants.

Levin voted "yea."

Riegle voted "nay."


