Garage price-fixing charges dismissed

Price fixing charges against 185 auto repair shops, new car dealerships and individual owners, all primarily from the Detroit metropolitan area, were dismissed last week by District Judge James E. Mies.

"The statute was never intended to cover services," Mies said Friday in 16th District Court, Livonia. He was referring to an 1899 state anti-trust law under which the Michigan Attorney General's office charged the small auto body shops, new car dealers and more than 100 individuals in February.

The defendants, the state alleged, fixed prices by agreeing to add a fixed percentage increase to the cost of body repair work.

The main defendant in the case was the Automobile Service Councils (ASC) of Michigan, a Livonia-based trade group. The state alleged the ASC, 27590 Plymouth Road, promoted the price fixing scheme through its magazine, "The Garage Key."

ASC Executive Director Dennis Liphardt declined comment Friday shortly after Mies dismissed the charges.

MIES GRANTED the dismissal sought by defense attorneys in

"We're delighted that the judge has agreed that this archaic state statute doesn't apply," said Eugene Driker, the service council's attorney.

"The problem in this industry is not the small body shops. The problem is the oppressive hand of the insurance companies who really control the prices of auto repairs."

The defendants were indicted in February by a Wayne County citizens grand jury, following a year-long investigation by the attorney general's economic crime division. The attorney general's office had called 33 witnesses before the grand jury, the majority of them insurance company representatives.

EDWIN M. BLADEN, assistant attorney general in charge of the economic crime division, declined to say if the case will be appealed to Wayne County Circuit Court.

"Were surprised," he said. "It's a matter we have to carefully review. Attorney General (Frank) Kelley has long believed the state's anti-trust law does include services." Mies said the auto body repair case was the first criminal price fixing case citing the 81-year-old state law. The attorney general's office said it was Michigan's first criminal price-fixing case in 50 years. The businesses and individuals cited had been charged with misdemeanors.

Shorly after the criminal case was brought in Livonia district court, the state also filed a civil suit in county circuit court citing similar charges. But Driker said the state has "done absolutely nothing" to pursue the civil suit.

man. MRS. VAN GILDER, 42, a self-employed tax consultant, and former Orchard Ridge campus student government president, ran fifth in the


June trustee election.
