Citizens lobby seeking change in court system

Calling the state Friend of the Court system "no friend to the children of Michigan," the Michigan Citizens Lob-by (MCL) has recommended reform of

Michigan," the Michigan Citizens Lob-ply (MCL) has recommended reform of the system. MCL made the charge at a press con-ference Monday in Southfield. The or-ganization released a report based on five years of research and investigation of the Friend of the Court system. "The major conclusion of the report is that the Friend of the Court is no friend to the children of Michigan," asid Kay McGowan, MCL special proj-ects director who wrote the 20-page study.

"The Friend of the Court was estab-lished by the legislature in 1919 to pro-tect children under 18 years old in di-vorced families.

vorced families.

"As an arm of the circuit court, the Friend of the Court has primary responsibility to help decide which parent gets custody, to make sure support payments are made and to make sure the child has the chance to visit the non-custodial parent. The Friend of the Court isn't working well. It no longer responds to the needs of the people it serves."

responds to the needs of the people in Serves.* During the past five years, according to Ms. McGowan, many persons have called the Southfield-based MCL to complain and ir frustrations about the Friend of the Court. The system hasn't kept pace with changes in society, she maintained.

LAST YEAR, one in every three marriages failed and more than half involved minor chidren, Ms. McGowan said. Because the Friend of the Court operates differently in all 38 counties and because there are no educational qualifications needed for appoinment to the court or staff—the system is designed to fail, she contended.

The costs of the system's failure are

high to the individuals and the state,"
Ms. McGowan said. "Mothers on welfare are affected because of unpaid
child support. Fathers are in jail because no other child-support enforcement system has been created.
"But the saddest victims are the children who are denied contact with one
of their parents and are lacking economic necessities because of unpaid
support."

The MCL report makes the following recommendations:

Changes in the Friend of the Court system. These include establishing qualifications for appointment, involvement of county commissioners in the appointment process, limiting terms of office, providing ways to rowe persons who don't do the job and creation of a complaint process.

Enforcement of visitation rights. These include a special staff responsible for problem cases, measures to follow when visitation is denied, starting with educational efforts and continuing through mediation or arbitration.
 Alternatives to imprisonment on onpayment of child support. Suggested are wage assignments, liens on assets, posting of a support bond, child support insurance, fines for refusal, referral to sources of training and job placement where needed.
