## **GOP** gains in Oakland

Republicans increased their strength in Oakiand County Tuesday by padding their Board of Commissioners majority by two seats.

The GOP, however, again fell short of sweeping the six countywide offices. The five incumbent GOP countywide officeholders easily won re-lection to four-year terms.

They include County Executive Daniel T. Murphy, 57, of Sylvan Lake, Prosecutor L. Brooks Patterson, 41, of Clarkston, County Clerk Lynn Allen, 50 of Drayton Plans, Drain Commissioner George Ruhn, 55, of West Bloomfield and Treasurer C. Hugh Dohany, 50, of Southfield.

GOP SHERIFF candidate James Y.

GOP SHERIFF candidate James Y. Stewart, 55, of Huntington Woods, lost to incumbent Democrat Johannes Spreen, 61, of Farmington Hills. Spreen has been sheriff since 1973. Vote totals in the countywide races were incomplete as of Wednesday afternoon. The city of Ponilate had not yet reported its results to the county clerk. The Republicans increased their county board majority by winning previously Democratic seats in Royal Oak and Berkley.

IN THE only contested Oakland County Circuit Court race, District Judge Robert C. Anderson, 55, of Waterford, was an easy winner over James F. McCarthy, 42, an assistant county prosecutor. Anderson narrowly missed winning a seat on the Oakland bench two years of Oakland's only exceeding the county for the county for the county of the co

SPREEN CARRIED the sheriff's race with 53 percent of the incomplete vote. As in past elections, voter ticket-splitting put Spreen over the top. Despite his close identification with Patterson, Stewart, Huntington Woods

public safety director, failed to match
the prosecutor's big margins in such
Republican strongholds as Birmingham-Bloomfield, West Bloomfield and
Troy.

The incumbent prosecutor tallied 69percent of the unofficial vote over
Democrat Martin Krohner, 35, of
Farmington Hills.
Patterson carried Farmington and
Farmington Hills by more than 16,500
votes. Spreen carried both cities by
more than 3,000 votes.
Patterson was a big winner in Water
ford Township where Spreen eked out a
93 vote margin over Stewart.

IN COUNTY BOARD races, most Republican incumbents won by big margins with the exception of Lillian V. Moffitt of Birmingham, who edged Democrat Barbara Rukes Goldman, also of Birmingham, by 1,200 votes. Republican James Lanni of Royal Coak will return to the county board in January. He defeated Kathleen B. Penner of Royal Oak, executive director of the county Democratic party, by 1,100 votes.

1,100 votes. Executive candidate Leward had de-feated Lanni in 1978.



Democrat Gilda Jacobs, an administrative assistant to state Sen. Doug Ross, lost her county commissioner bid to Republican John Olsen, Huntington Woods Mayor, by 375 votes. Jacobs had defeated the incumbent Democrat, Kennels Reth in the primary. Kenneth Roth, in the primary.

Tisch loss slim in **Oakland County** 

The Tisch tax cut proposal failed to ride Republican Ronald Reagan's coattails to a win in Oakland County Tues-

day.

While Reagan tallied nearly 60 percent of the unofficial county vote, Tisch, Proposal D on the ballot, was a narrow loser.

narrow loser.

Incomplete county vote totals showed Tisch trailing by 14,700 votes in the county. No votes prevailed by a 51 percent margin. County officials were still awaiting the city of Pontiac's vote totals Wednesday afternoon before posting the final county-wide tallies.

REAGAN'S MARGIN in Oakland, as-suming a normal Democratic vote in Pontlac, was similar to former Presi-dent Gerald Ford's showing in the sub-urban county four years ago. County voters didn't like any of the state-wide ballot proposals, sending all seven to defeat, including the three property tax referendums and a pro-posed income tax hike for new prisons. Proposal A, the so-called Smith-Bul-

lard plan, captured only 20 percent of the unofficial county vote. The legisla-tive-executive coalition plan, or Pro-cosal C, was rejected by some 77 per-cent of the county voters. Proposal B, which would have low-ered the legal drinking age to 19, was rejected by more than 60 percent of the county's voters.

THE TISCH referendum, which would have cut property tax assessments by 60 percent, was nearly uniformly favored in the county's northern

townships.

However, Proposal D only carried one large county city — Troy, by about 500 votes.

500 votes.

Tisch lost in Southfield by about 11,000 votes and in Royal Oak by 3,700.

The tax cut was a narrow loser in West Bloomfield and a nearly 2,000 vote winner in Avon Township.

According to county Elections Director Howard Altman, an estimated
