Murder suspect to undergo preliminary exam

Gregg has been charged with first degree murder in the Feb. 8 slaying of Juanitz Waluzak. He is also charged with murder in the commission of a felony, first degree criminal sexual con-

duct and two counts of assault with intent to commit murder.
