ing an unloaded gun, a toy gun, or even
a concealed finger, said the prosecutor.
By his participation in the scheme to
steal Reif's car, Mandlebaum said,
McMillion showed wanton and reckless
disregard for Reif's life — one criteria
for premeditated murder.
Crosby's attorney, Gary Ladue,
saked Hand for the opportunity to
cross-examine the prosecution's chief
witness, Adrian Fleming, 18, O Detroit.
The judge denied the motion without
prejudice, explaining the opportunity
to cross-examine Ms. Fleming would
be available in circuit court.
Attorney Ladue said Ms. Fleming
"had reason to lie" to protect McMillion because she is his griffriend.

BOTH DEFENSE attorneys indicated they would appeal the decision by Judge Hand to order the co-dendants held without bond for trial. Waterman and Ladue said the circuit judge sent the case back to district court only to resolve the problem of charging both men on unconstitutional, automatic

first-degree murder charges.
Judge Hand disagreed outside the courtroom. Because the case was sent back to district court, both men will have to be tearraigned in circuit court on new information, said Judge Hand, "and the 180-day period starts from their second arraignment."
Webster was unavailable for comment on Hand's action to order both men jailed without bond.


