Businessman mourned after shooting death

Funeral services were held yester-day for Paul Trabulsy, a 1979 North Farmington graduate, who was murdered early Senday morning in Detroit. The 32-year-old manager of family-operated inruliure stores in Plymouth and Southgate died in the emergency room of Grace Hospital. He had been shot in the chest about 1:30 a.m. in a parking lot near the Virgo bar on West Eight Mile.

"He was a brave kid, and he didn't back down from anyone," said Trabulsy's father, Joseph. "He told his friend to duck because he didn't want him to get hurt."

The shooting took place after Trabulsy and Wahrman had pulled into a
parking fot to wait for friends, according to Wahrman.

window, identified themselves as police
officers and asked them to get out of
the car, said Wahrman.

WARRMAN DUCKED down, started the car and sped away. He called for

was carrying about \$1,000, most of it in
\$100 bills, police said.

Election candidates talk money

Taxes, a proposed police building, park development and capital improvements dominated the third debate this week between incumbents and challengers vying for four seats on the Farmington Hills City Council.

Six of the soven candidates met at the invitation of the West Bloomfield-Farmington branch of the League of Women Voters Tuesday to outline their political ideas.

Candidates natticipating in the de-

Candidates participating in the de-bate were incumbents Jack Burwell,
Fred Hughes and Donn Wolf; and chal-lengers Melissa Levine, Joan Dudley and Terry Sever. Joe Alksteeb was ab-sent.

nt. Dudley tossed out the first reference

Dudley lossed out the first reference to the city's tax rate.

"Doing overything. Doing nothing. Doing something. That is the issue in this election. To say we will never reise taxes without a vote of the people is to do nothing." said Dudley, a former councilimember and charter commissioner. He noted the city's tax rate does not come close to that allowed in the city charter.

BUT WOLF, a supporter of Richard Headlee's voters' choice amendment, urged taxes not be increased without a vote of the people. He pointed to his past record of stopping tax increases in Farmington Hills.

"Somebody has got to say 'stop," said Woll, who is winding up his first four-year term on the city council." I want to continue to run efficient government on the money people provide to the city council."

In a prepared statement, Alkateeb said he questioned the stand of candidates who claimed they were for low taxes.

"I and the people of this city want to know what 'low taxes' mean," wrote Alkateeb. "I am opposed to tax increas-

SOME OF the approximately 25 residents who attended the debate asked whether certain city projects, such as the proposed police building, abould be paid for on an "asyou-go" method, or through bonds.

Bonds, Hughes replied, would be the best method of financing the estimated \$1.5 million police facility. He said current and future residents who benefit from the facility would pay the bill.

CLAMMING "everybody is jumping to conclusions that we are going to build a "ay Mahal tomorrow," Burwell said the building can be constructed in an "economic and judicious way." But he offered no specific opinion on how to pay for the building. In his statement, Alkateeb wrote that the proposed police building "is an example of poor fiscal responsibility" because, at \$40, the cost per square foot is too expensive.

Referring to Alkateeb's cost estimates, Dudley said, "We are not building say besic two-story office building." She pointed to sophisticated and technical needs in a police station, such as dispatch and lock-up facilities.

"Do the job now and do it right," Dudley said. She said she opposed building a structure that can only accommodate immediate needs and wanted one which could be expanded later.
