

M. A. C. SCHOOL OF AIR**TAKES SUMMER RECESS**

Michigan's first agricultural radio school, broadcast this spring from the Michigan State College station, WKAR, closed on Friday, May 8, for a summer "recess." It is understood that the school will be reopened next fall with a considerably expanded curriculum.

A check of registration for the five courses included in the school this spring shows that more than 2,500 formal enrollments were received at the college Short Course office. As a great many enrolled in more than one course, however, the number of individuals does not run as high as the enrollment figure. In addition, it is estimated by those in charge of the course that many thousands who did not bother to send in registration blanks listened to the lectures. While plans have not been completed for next year's school, announcement has been made from the college extension office that the success of this year's broadcasting guarantees another series of courses, with more variety in the subject matter. It is probable that the air school will be started about the first of November, running for five months.

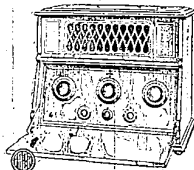
