and the Michigan State College, will be effected at meetings to be held in Grand Rapids and Lansing early in September, according to officers of the association.

The new poultry organization will supervise certification of hatcheries, poultry flocks, and baby chicks, under college inspection, much after the plan of the state crop improvement association, being a purely co-operative venture. The aim is a guaranteed supply of pure-bred poultry products for the farmers and hatcherymen of the state.

All who raise poultry and are interested in the new plan for certification are invited to attend a meeting at Grand Rapids September 3 or one at Lansing September 4, according to J. A. Hannan, member of the M. S. C. poultry department and an officer of the association.
