File for House seat as planned

Prospective candidates for the state House of Representatives are being urged to fille for office as planned despite last week's court ruling that legislative districts were drawn up unconstitutionally.

With the filling deadline at 4 p.m. Tuesday, both Democratic and Republican county officials said they believe most of their nominees are secure. But they won't be certain until the Michigan Supreme Court reviews hast week's ruling by Oakland County Circuit Judge George LaPlata.

"The whole thing is a little nebulous," aid Kay Penner, executive director of the Oakland County Democratic Party. "We have absolutely so idea what will happen, so we're encouraging candicates to continue to file."

Until the high court rules, the Oakland County clerk's office is accepting nominating petitions for the Aug. 7 partisan primaries on the basis of districts drawn up by the Michigan Legislature last December.

Generally, Republicans have been unhappy with the new reapportionment plan because districts slice across city and township boundries more frequently than under an earlier plan.




