Insurance crisis! Many bars 'go bare' as costs skyrocket

If you're injured by a drunk driver and think you can collect a million off the bar that served blim, think again. "Seventy percent of Michigan lavern owners no longer carry liquor liability insurance," said Ronald Y. Gutman of the Farmington Hills firm of Kaufman and Parine.

Even prestigious spots such as the Park Place in Traverse City can't al-ford insurance. Park Place discontin-ued serving drinks. "Francesco's on Michigan Avenue closed its door rather than go bare," reported state Sen. Patrick McCol-lough, D-Dearborn, whose district stretches to Garden City.

"PLAINTIFFS THINK they can get more mosey from a tavera owner with a high insurance policy," attorney Gui-man told a state Senate committee re-cently, "But they may end up with nothing if the trend of luque establish-ments going without insurance coolin-ues because carriers refues to write policies in Michigan. "Reasonable caps must be set on dram shop awards to woo lasurance carriers back to Michigan," Gutman said. The state must require madatory "reasonable and affordable" insurance coverage for sellers of alcohol, too, be added.

added. He urged that Michigan's dram shop law be changed to prevent "double re-

covery," where a plaintiff is paid dam-ages by both the drunk driver and the tavern owner.

Gutman testilled at hearings before a subcofinnities the Senate Select Com-mittee on Civil Justice Reform, which adopted his recommendation that bar-tenders be trained in how to recognize drunken behavior.

THE SENATE panel wouldn't rec-ommend ending dram shop liability en-tirely. The liability is based on old case law holding that the person who serves a druk driver can be sued for dam-ages done by the drunk driver. In its report — part of a larger book-let also covering medical maipractice and governmental liability — the secan-tors said "the dram shop system of lia-bility must be preserved. (But) the dram shop liability system is breaking down."

dram Bob Hability system is orconan-down." The committee proposed limiting the legal concept of "joint and several lik-bility," in which the defendant with the "deepest pockets" could wind up pay-ing the full judgment. It noted dram shop haw was enacted to make taverns "a secondary source of

compensation for innocent victims" in-jured by drunk drivers. "In practice, however, these licensoes have become the primary source of compensation."

TAVERNS losing lawsults would be allowed to pay off non-economic (pain and suffering) damages over \$100,000 in installments. The installments would cover only the injured person's life-time.

"If the injured party dies before that time (when court judgment is paid off), then the net result is a substantial pay-ment to the belrs who are unintended beneficiaries of the original judgment," said the Senate committee. Suppose a person drinks at several hare before causing an accident. Should all be subject to lawauit? No, said the Senate panel. "Only the last license patrontized by an alleged intozicated person is liable for dam-ages caused by that person," it suggest-able prise that would be a "rebutt-able presumption."
