Citing family reasons, James Elsman, 51-year-old Birmingham attorney, said he is withdrawing from the race for the Republican U.S. Senate nomination.

But a rival camp said Elsman never was officially in the race.
Will Elsman support either Jim
Dunn or Robert Huber for the
chance to tackle incumbent Democrat Donald Riegle?

"It's not likely I'll decide until about a month of watchful walting," Elsman said. "I want to see if Huber can run a modern campaign. I want to see if Dunn is Senate timber."

BILL MeMASTER, public relations man for Huber, said Elsman never had filed three reports with the Federal Elections Commission. These included a statement of candidacy, a statement of organization and reports of receipts and disbursements due April 15 for an authorized committee for the first quarter of 1988.




