

Dems' lone contest

Party backs Trivax over Marcuse for county clerk

Last May Democrats were hustling desperately to fill their Oakland County ticket. And then they found themselves with two candidates hoping to win the Aug. 1 primary for a run against Republican Lynn D. Allen, a 20-year veteran as county clerk/register of deeds.

In Democrat Jack Faxon's district. In 1984 he ran for county commissioner against Republican Jack Olson of Huntington Woods.

A former precinct delegate, Marcuse said he has worked on the campaigns of Michael Dukakis for president, Congressman Sander Levin and the party "get out the vote" effort. A University of Michigan graduate, Marcuse has done graduate work in management science and completed a computer programming course at Central Data Institute.

MARCUSE ADVOCATED setting up simple computer terminals at the clerk's counter so visitors could look up some information themselves. Like most Democrats, he advocated setting up clerk-register satellite offices in the south end to let people avoid trips to Pontiac. Marcuse worked 11 years as an internal auditor at Occidental Life in Los Angeles before coming to work for the county seven years ago.
