# Officials quiet on reported gambling probe

Federal officials wouldn't comment this week on newpaper reports that a grand jury is Investigating West Bloomfield Township resident Henry Alan Hilf of gambling. Hilf was named in the Detroit Free Press and News last weekend as the subject of probes by the FBI, IRS and a grand jury for laundering money through stores owned by former Bloomfield Hills resident Emmet Denha.
