Shooting suspect to undergo tests

liminary examination on the charges against Hopkins. But Hopkins waived the rule entitling him to the exam within 12 days following his arraignment. The preliminary examination is expected to be scheduled within five days after receipt of a report on Hopkins from the Ypailanti Forensic Center.

Hopkins stood mute to the charges at his Parmington Hills jail-cell arraignment June 1, the day after the shootings. A not squilty plea was entered on his ball. If convicted of first-degree murder, he faces life in prison.
Hopkins remains in the Oakland County Jail without bond.
The shootings, with a high-powered shodgun, occurred about 7:10 p.m., Friday, May 31, in front of neighbors and motorists driving along Eight Mille, near lakster. No one else was injured. A business in

the area was damaged by shotgum fire.

Hopkins, who lived temporarily at the Inkster Road house surrendered to Livenia police immediately after the shootings on the Farmington Hills-Livenia border, police sade, and the shooting to the Farmington Hills-Livenia border, police sade, and the shooting within about two weeks before in Detroit.
