Drug store owner challenges sign law

The owner of three Farmington Maple Village drug stores is the first to challenge part of the city's new sign law. Alvin Wander believes the ordi-

Alvin Wander believes the ordi-nance, which restricts temporary window signs to 25 percent of total window space, is unfair to smaller merchants who need the signage to promote their businesses. The ordi-nance was passed last November af-ter much discussion by etcy council members and planning commission-ers.

"We certainly appreciate the need to beautify ... but we have to find a way to work together," said Wander, who adds that he must compete against gland drugstore chains who do that he had to the competence of the

Wander received three written warning notices from the city, and warning notices from the city, and appealed to the council in early July for sign variances at each of his stores. He owns stores in downtown Parmington, at Grand Hiver and Drato roads, and most recently at a renovated and eleaned-up location at the Uptown Plaza at Grand River and Mooney. Wander also owns stores in An Piaza at Grand River and Arber, Yeslandt, South Lyon, Westland, Warren and Lincoln Park, where he said he has had no sign problems.

WANDER SENT a letter to Mayor Shrirley Richardson hast September warning that the new sign ordinance would burt smaller businesses, especially in a tough economic climate

The council tabled the July 1 vari-The council tabled the July I variance request with several council-people asking for more information about the Maple Village situation. The council is expected to reconsider it at the Aug. 19 meeting. Councilman Raiph Yoder called the 25 percent law "too restrictive" and would like to see merchants allowed another 10 percent of their window space for advertising of services to customers.

Wander sald he is pleased the council is considering the matter. "We were delighted with the reception we got," he said. "They were willing to listen."

Maple Village's Uptown store manager Arlene Vecsel said the store regularly draws customers with signs which tout low milk and diaper prices. "This helps every body." she added "It's been a big help in sales."

THE CITY is expected to consider the amount of window space when reviewing the Maple Village requests since some of Wander's stores have much smallel windows than others. This is not the first time the issue of temporary signs has been debated eccently. Last fall, as the council was considering changing the sign
