McGINNIS, HOWEVER, said that Hopkins never sought out Carter and Preston. The two arrived at the Parmington Hills house and went into the house uninvited. Marur disagreed and quoted Mikel Hopkins' testimony that he told them he had their money and to come in. "It is the contention of the defend-
