Laws gobble city powers, say 2 towns

Farmington and Farmington Hills have both taken stands against pending state legislation city council members asy will encroach on local control — commonly called "home rule."

The Farmington City Council word unanimously Dec. 1 to object to what it said is state interference in locally governed matters. The Farmington Hills council adopted a similar measure on Nov. 18.

Residents rap suit settlements

Some Woodcreek subdivision residents are just glad two lawsuits over property near their nelghborhood are over. But they continue to be concerned about office buildings crosaching on their homes.
"Both of these developers sought to overturn existing residential zoning in favor of office zoning," said hank Murawski, president of the Woodcreek Civic Association. "We're not extremely happy with the results that came out."
Murawski and two fellow Woodcreek residents -- Jack Holmes and

John Hutchinson — expressed their feelings about the two lawsuits before the Parmington Hills City Council in late November.

The longest-standing lawsuit, Northirly Associates versus the city Farmington Hills, has bung over Woodcreek residents' heads for 10 years. The second suit, Providence Hospital versus the city, has been active for three years.

Both suits are now resolved by consent agreement. The city council is expected to approve a stipulated order to approve the negotiated settlement for dismissal of the Northir-

Farmington puts strings on transit backing

Farmington city officials want a solid plan of action before helping a financially troubled tri-county trans-portation authority. "We obviously need a lot more in-

"We obviously need a lot more in-formation before we take any ac-tion," Mayor William Hartsock said Monday, suggesting the city keep the issue on a back burner white request-ing a formal plan.
"I agree there has to be a plan in place before we take any action on funding."

The city council will make their request of SMART — the Suburban

Mobility Authority for Regional Tranportation which operates a regional bus system in Wayne, Oakland and Macomb counties.

SMART officials have said that, without help from local governments, the bus lines in Oakland, Wayne and Macomb counties could shot down as early as April.

They also have requested their suburban system be merged with the Detroit transportation system.

THE AUTHORITY is reportedly \$4.7 million in debt this years, and projecting a \$19.3 million debt over

Although they wrote to local communities requesting support, SMART officials did not specify exactly how they want local cities to help, according to Farmington City Manager

Robert Deadman.

SMART's problems come at a time when cities are waited, with most facing revenue decreases because of

clining sources.

SMART has at least two routes through Farmington and helps to subsidize a taxi program for seniors and handicappers here which could be affected by changes. One route begins at Drake and Grand River and runs east on Grand River then south of Middlebell to Metro Allorott. The other begins at 12 Oaks Mall and runs along Grand River through Farmington ending at Grandview near Seven Mile Road.
