

City wants Carpenter Lake land

The privately owned Carpenter Lake property, 29 acres of land described as "the most beautiful natural space in Southfield," is still in the city's shopping list. But the price continues to be a problem, city officials say.

The city's last appraisal set the value at \$385,000. A recent appraisal for the property owners valued

it at \$850,000. "I don't know whether my appraisal is crazy or their's is," said co-owner James Clarkson, a former Southfield mayor and district judge. "I think we're going to have to arbitrate an appraisal."

Southfield first became interested in buying the property on Carpenter Lake, a dammed section of a Rouge River tributary southeast of 10 Mile and Inglish in 1984. But it

wasn't until late 1990 that it sought and won a \$300,000 state grant to pay for 75 percent of the purchase. The city matching share is \$100,000.

In 1990 developer Robert Wolfson had an option to buy the site and proposed to build a residential subdivision named Hidden Valley. Clarkson launched a new wave of

negotiations with a presentation to city council at its May 4 meeting. Clarkson said Wolfson had his option to buy the site and that Clarkson and Judith Wiser are equal partners in the ownership.

"I told council, I want to talk with you collectively, in a closed or open session. Just tell me when," he said in an interview.
