With eight days to go before the election, the 11th U.S. Congressional District race between Democrat Walter Briggs and Republican Joe Knollenberg is heating up.

Both candidates have been issuing a stream of press releases, and Briggs has gone on the attack. His latest move was te hold a rally last week at the Northland Family Planning Clinic in Southfield featuring pro-choice Republicans who are botting the party in favor of Briggs.

Knollenberg has stood fast on
his opposition to abortion, saying
he supports adoption instead.
However, he said the issue has
been blown out of proportion, and
the economy is seen by most voters as the key issue.

"There are so many issues fac-ing the people of this district that it is too bad my opponent is a one-issue candidate and has to stoop to such campaign tactics," Knollenberg said.

He said he has a wide range of supporters including pro-choice advocates.

"I believe in a woman having the right to make her own deci-sion when it comes to abortion," said Pat Hardy, a Knollenberg,

"I also feel there are so many, other important issues in this campaign. I am supporting the candidate that I agree with the other 98 percent of the time."

Tom Schellenberg, another Knollenberg supporter, said, "Those women voting strictly on the issue of choice stand to lose the most under a Democratic administration. Women are the first to be harmed when the economy is down. Single issue voters are in most cases their own worst enemy.

"There may be an effort to focus on one issue. This is a minissue campaign," said Knollen-

berg.

Knollenberg said he has other sharp differences with Briggs, such as Knollenberg's support of the presidential line-item budget veto, his support of term limits for elected officials and different views on eliminating capital gains tax. He is focusing on those is-

"Our campaign has not taken on a negative tone. They pose me in a light that is very negative," Knollenberg said.

"We will be visiting the violators more often," said public safety Director Frank Lauhoff. "We are serious. We want them to be more careful."

Lauhoff praised the 13 city businesses that passed the Oct. 16-17 spot check, in which public 16-17 spot check, in which public safety officers and a 19-year-old college student and criminal jus-tice major from West Bloomfield visited the businesses and at-tempted to purchase liquor.
