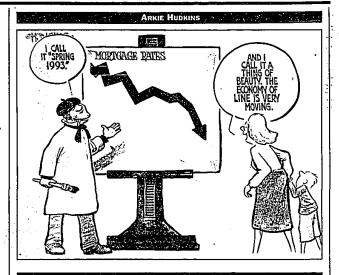

He perpetuated myths that military leaders' opposition was because openly homosexual behavior was a possibility.

Military leaders aren't that shallow, and most certainly not General Powell.

Having gays openly serve would be a disruptive influence in a military organization. The disruption begins with the perception of the majority of military people that homosexual behavior is something personally or morally repugnant, and that they have no right to feel or express that perception.

Duty performance isn't the issue; behavior is the issue, a military organization must be cohesive and disciplined in order to function and survive in a combat environment. Anything that would cause disruption, or destroy unit cohesiveness and discipline, is anathema to military readiness.

cohesiveness and discipline, is anathema to military readines. The sacrifices of many brave, gay service members is also not the issue. The military docent function solely an individual effort. It functions on teamwork, excellence, and the ability to fight and win if called upon. Given that basic function, social experimentation would be inappropriate.

As a black American, combat veteran, career Army officer, and now a member of the Army Reserve, I know from sad experience what happens to a unit when gay soldiers openly declare themselves. It nearly destroyed a unit I commanded.

Yes, gays are people too. People with guaranteed constitutional rights, such as equal protection under the law, the right to vote, freedom of religion, speech, and so forth. Yes, homophobia is wrong. Making unfounded, nonsensical generalizations about any people is wrong; but so is applying the generalizations such as racist, sexist and homophobic to those who don't want to see our military organizations critically disrupted. We worry about
