visual art. They can enjoy the performances, learn about dance therapy, or make something, said festival co-chair, Connie Lott. "We want to invite schools from all over the area to come over and take a look."

Very Special Arts was founded for children and adults who could not participate in the sports of Special Olympics. The festival serves as a model for the ways that the arts can be used to integrate the disabled and non-dis-

abled in cultural and educational activities, said Lott. It is part of a larger, ongoing program of year-round arts experiences taking place in schools and communi-ties.

The Burger Choir will perform 10:30-11 a.m. Friday; the School-craft Players 11:30 a.m. to noon Saturday. The 30 member choir is the only autistic choir in the country, and one of only two in the world.
