1. What changes, if any, would you advocate in federal policies to solve the problems of the cities?

2. What changes, if any, would you advocate in U.S. policy toward Southeast Asia?

3. How do you propose to meet the demands of the federal budget?

Candidates were asked to limit their replies to 50 words-per question. If the answer exceeded this limit, it has been cut. Answers have not been edited -- they appear as written by the candidate.

which place emphasis on private capitalization. Our cities require development of individual initiative through adoption of long-range programs like home-ownership replacing the self-perpetuating tenant concern. Residents of underprivileged areas must have a meaningful stake in the community."

2. "An all Asian peace-keeping force should be created. Approx. one billion free Asians live in Southeast Asia. I also favor meaningful Congressional involvement in the general decision-making

process pertaining to our policies in Vietnam. March 18, 1968, I co-sponsored a resolution calling for immediate Congressional consideration of this issue."

3. "The Federal budget requires an immediate reappraisal of all major domestic and foreign expenditures. A sound set of priorities must be established to assure that expenditures are made wisely. Essential Fed. programs must be adequately funded while those which can be safely and justifiably deferred or eliminated must be handled accordingly."

1. "A massive federal commitment must be made to solve the problems of our cities. The spotty efforts toward urban renewal and welfare and better education which have been made so far should be replaced by a unified approach to deal with these problems as part of an interrelated whole."

2. "American troops should defend only central strategic points. The South Vietnamese--the only ones capable of finally defeating Communism in South Vietnam--must shoulder the work of pacification in the war to save their own country. And to prevent future Vietnams, we must rethink our entire approach to Asian nationalism."


3. "By immediate reform of the federal tax structure to eliminate the lucrative abuses presently practiced by large corporations and some individuals, I would also support a plan advanced some years ago by Sen. Paul Douglas, to retire the national debt through revenue from federal royalties on western shale oil fields."
