Legislation would strap banks

"We will curtail the ability of state-chartered bunks to com-pete," warned Rep. William Keith, D-Garden City. "We will not have one state-chartered bank in Michigan.

"We used to have 200 state-chartered savings and loans; now we have one," said Keith, arguing that tough state regulations will backfire. Of 205 banks in Michi-gan, 166 have state charters, and

gan, 160 have state charters, and 45 are national, said the former

banker.
"Banks should stick to the banking business, and insurance companies should stick to the insurance business," said Rep. Mike Griffin, D-Jackson, summing it up.

Rep. Jerry Vorva, R-Plymouth, took a middle ground. He supported a failed amendment that would have prohibited a bank from having an insurance agency in the same office; prohibited loan officers from selling insurance; provided for strict fines; and applied industry standards for use of qualified insurance agents.

In the end, the House approved 80-25 the first of a four-bill package designed to keep banks, asvings and loan associations and credit unions from selling insurance.

Banks already operating insurance agencies couldn't be forced out, said liep, Bill Martin, it-Battle Creek, floor manager of the package. Banks already are selling limited annuities and credible life insurance. Three major Michigan bank holding companies. Comerica, NBD and Old Kent—own insurance agencies of some sort.

The issue grose Jan. 25 when the state Supreme Court ruled the state insurance commissioner lacked authority to stop Luding-ton Savings Bank from buying an

ton Savings Bank from buying an existing insurance agency.

"A lot of people view this as a free market issue," said Martin.
"But insurance and banking are extremely highly regulated industries. The issue ian't about whether banks are good or bad guys, or whether insurance companies are good or bad guy.

Martin said credit union lend-

ers were offering "insurance at no cost" but actually rolling the cost of life insurance into the loan. "I don't know if that's blackmail or good business practice."

Backers of the package also argued lenders could subtly coercive borrowers into buying their agency's life, home or auto insurance or engage indirectly in rebating of commissions.

Keith, author of the statewide banking law in 1986, scoffed at talk about "corrion" because "the industry has not had one complaint about coercion. If 1, and one complaint about coercion. Founded in Pleasant Ridge and Royal Oak and now expanded to Pontine, The Sanctuary will cele-brate its 20th birthday from 5:30-8 p.m. Friday at the Oakland brate its 20th birthday from 5:30-8 p.m. Friday at the Oakland County Farmers Market in Royal Onk. Ice cream and cake will be free to the public, but guests are asked to bring some non-perishable food item to help feed the children in the Pontiac and Royal Oak centers.

Former staff members will be returning for the birthday cele-

bration, including executive directors Lisa Kaichen and Mary Schnefer. A flight of homing pigeons will be released, symbolizing the emphasis on returning home. There will be clowns and halloons, with picnic-style food available for purchase.

"The community has been wonderful. We want to make this birthday party a gift to all of our good neighbors and friends," said Meri Pohutsky, director of The Sanctuary.

The organization got its start following difficult times for youngsters who gathered at Royal Oak's Memorial Park in the early 1970s after they were barred from

congregating at the shopping cen-ter across the street at 13 Mile Road and Woodward. Some of the youths had run away from home and had no place to live. They slept at the park and nearby pub-lic places and often were confront-ed by police.

Volunteers who saw Volunteers who saw a need found an abandoned photo studio in Pleasant Ridge as The Sanctuary's first home. It was used for sheltering children and counseling their families and it moved to Royal Oak in 1980.
