When she went home from work that night, she testified that ahe saw Lavzck's car parked on her street. She drove away and went to her flance's house.

"I was really scared," Stewart said. Lavack had given back the key to her realdence in May, she said, but she didn't know if he had a copy made.

Perez and two friends, Scott William Smith and Robert Gar-vin, went to Stewart's residence and found Lavack standing near the front door inside the house, Smith testified.

Smith testified. Smith said Lavack came out-side and was told again that Stewart wanted to end the rela-tionship. Lavack nodded, went back into the house and picked up a map book that belonged to him, though something else was concealed under the book, Smith said. Police believe it was the 9 rom handrun. mm handgun.

When asked if he was certain Lavack was inside Stewart's house, Smith testified, "He is the one. No doubt." Stewart notified Westland po-lice and filed a stalking and bur-glary complaint against Lavack. Warrants charging him were is-sued about the time Stewart was abducted a week later.
