EPA crackdowns hit area businesses

U.S. Environmental Protection Agency Region 6 has taken a series of legal actions against 12 Michigan companies, including a Livonia gasoline station, since new chlorofluorocarbon (GFC) regulations became effective for the auto repair industry. Saveral local agencies also cooperated in the enforcement effort plaspecting automotive gazages, dealerships, and auto-parts stores.

The Livonia gasoline station cited is Bell Creek Amoco for no training, a \$15,000 fine.

The refrigerant regulations, imposed under the Clean Air Act, became effective Aug. 12, 1952. Refrigerants containing CPGs destroy the upper cosne layer that protects the earth from harmful ultraviolet rays.

The rules require that refrigerants be recycled when servicing or repairing auto air conditioners. Auto technicians must have certification that they have been trained to properly handle refrigerants.

The rules also ban the sale of small cans of sutomotive refrigerants.

it-yourselfers from releasing from.

"Overall, we are pleased with the results of our investigations," said David Kee, regional director of the Air and Radiation Division. "Many companies are following the rules, but a few either were unaware or didn't believe they would be caught. These actions show that EPA is serious about enforcing the CFC rules."

Representatives from the companies may request meetings with EPA to discuss the allegations.

The act allows EPA to impose administrative penalties of up to \$25,000 a day for each violation. Local agencies will continue to help EPA investigate complaints and inspect automotive Recilities.
