Owners can seek homestead exemption

Homeowners who owned and occupied their homes prior to May 1 and did not previously apply for the homestead exemption on their school operating fax may submit an application to their local government in time for the December board of review.

The exemption will be granted


to qualified homeowners and will suply to all regular school opera-ting tears for the tax year 1994. The exemption allows owner-scenpted property to be taxed at 6 mills for school operations in-stead of 24 mills, which is applied to business and non-homestead


property.

If a homeowner has paid the

non-homestead school operating tax rate in the summer, the excess-tax paid will be applied to the homeower's winter tax bill orres to funded by the local government.
