My parents celebrated their 61st wedding an-niversary six months before my mother died. My father passed away just a couple of years afterward, in 1993. Like most people who dis-

cover that middle age really begins when your parents have died and there is nobody left but you to take the high, hard ones, I miss my par-ents very much, especially around Memorial

In these days when the right wing has made ethics and morality four-letter words of com-mon political discourse, I like to remember how solld they were when confronted with instances

solid they were when confronted with instances of unfairness or, as my mother would put it. "bad manners." Here's a sample that I've been musting about as Memorial Day approaches. My parents used to be members of a rather grand country club just outside Ann Arbor. Many of their friends were, too, including a cortain couple. The wife was a full-blown WASP blueblood; the husband was a distinguished physician and psychiatrist. He was half Jewish. World War II came, and everybody went off to

"Hi, Tony," ho'd say to the greenskeeper.

"Just great, Mr. Power," came the reply, "But we keep having the darmedest trouble with gophers digging up the greens."

My father would just walk on, a little grin on his mouth. He never said anything, but he kept up the vendesta for years and years.
