That leaves one open seat unchellenged as the term for board president Joe Svoke also expires. Svoke said he will run in the June 10 school election.

Cities would rather live without residency bill

Farmington and Farmington Hills officials would like the State of Michigan to but out of their business when it comes to residency requirements for city employees.

State Sen. Devid Honigman, R. West Bloomfield, is sponsoring a bill that would not allow city's to require employees to live within the city limits. The bill, being considered in the Senate, would still have to go to the House.

"It's immoral for the government to tell people where they can live," Honigman said Tuesday.

The senator cited cases where men and women could not marry because their jobs required each to live in separate cities.

"There are a million reasons why someone would not be able to live where they work, such as taking care of a parent," he said.

But cities like Farmington and Farmington Hills would be hurt by such a isw.

Whinnery said other city employees do not have a residency requirement. The city has also negotiated an agreement that police officers can live in Millord, Highland Township or White Lake Township as well as within the 25-mills limit.

"That was negotiated eight or nine years ago so that officers could find affordable housing near water," he said.

Whinnery said requiring other city employees to live in the city would not only hurt recruiting efforts to get top employees, but would probably run afoul of the courts.

"In some cases, requiring people to live where they can't afford to has been viewed as an impediment to employment resulting in job descrimination," he said.
