involvement with the council of homeowners in 1976, Farming-ton Families in Action, the Council for the Arts, and election to the Farmington Hills City Council beginning in 1986, where he served eight years including a year as mayor.

With less exposure than most political races, both candidates did their best to explain the role of a commissioner.

"We need to have elected representatives making the decisions," he said. "That would hake it more streamlined and effective."

making efficiencies that included saving \$1 million in the county's pension plan, privatizing auto repair, selling 60 of the county's cors and turning a \$24 million shortfall into a \$7 million sur-

ns. Both candidates said they had Both candidates said they had opposed a public safety millage that was passed by Farmington lills voters but had wanted the community to decide the issue. Lopez said he would lobby against local maney going to pay for programs in other counties. Wolf said that he would like to get more money back to Gakland County, a donor county, and

Wolf, who opposed the SMART millage that also passed, said his opposition was based on incofficiencies at SMART and the authofity's refusal of a u d i t requests.
