The article questioned how Young had come to have two of the missing weapons, both of which were signed out by Hart. who's now sorving a prison sentence for embezzling diy funds.

"The only thing I have" as chief of police "is my integrity." Divyer said Thursday afternoon after facing a stream of nowspaper and tolevision reporters an enduring citizens barbs.

Dwyer related how one Hills officer had gone to lunch Thursday and the guy at the sandwich shops said, Tell the chief he better find those guns."

The chief said four of the guns – two enub-nosed 38-caliber police specials, a shotgun used in Detroit PD narcotics raids when Dwyer was chief of that section and a sniper rifle – had been locked in the Hills armory and would returned to Detroit by Thursday.

He said he refused to allow television crows to film the return of the weapons. The other two weapons, he said, were probably turned in and reassigned to someone else in narcotics.

They were never brought out here and were probably lost in their audit, which is way overdue, of course, 'Dwyer said.

The chief said he doesn't collect guns.

lect guns.

Besides the annual weapons inventory, the FHPD's policy since 1995 has been to allow retired officers to purchase, at the then-current, new-gun replacement cost, the duty handguns provided by the department. The policy covers officers retired since Jan. 1, 1930.

Officers also may carry their own personal backup weapons on duty, he said, but these must be handguns approved by the department and the officers must qualify with them.

The retirement gun policy took effect after the department switched from .357 Magnum revolvers to the current 10-millimeter Smith & Wesson semiautomatics, Dwyer said.

Regarding the Detroit weapons, the Hills chief said he had properly signed for them when he was Detroit Narcotics Section chief and only found them while unpacking in 1985.

He then asked the DPD several times to pick up the guns, thinking they would do so as a professional courtesy, since he now was a chief of police.

After a while, he said, "I had assumed somebody had come for them" and he forget about them until he got the DPD missing-weapons page with his name on it at mid-weap.

Dwyer noted the page included a former police commissioner who's now a judge, but said that apparently wasn't published.

The Detroit reporter told Dwyer his name was prominently featured only in that paper's Oakland County edition.

The investigation was sparked when a Detroit gallery conducting Young's estate sale sought a routine check by state police of Young's gun collection.

Dwyer was with the Detroit PD 23 years, rising to the rank of commander.

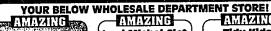

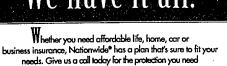
