Halloween for Kids party: For the past 13 years, Walled Lake Schools and several of our municipalities have supported the efforts of the Halloween for Kids Committee to provide a party for youngsters in the district as a safe alternative to trick-or-treating on Halloween. The party is held at Western High School, and for the past couple of years, more than 3,000

children and their parents have attended. The committee requested, and received, \$900 from the board, the same contribution as in the previous two years.
