istering 40 to 50 miles per hour, the blaze couldn't be contained within the business and spread to the adjacent Hong Kong Chinese Restaurant, Goss said the cause of the fire was still unknown as of late Wednesday morning.

Two Farmington fire units and five units from the Farmington Hills Fire Department battled the blaze, finally extinguishing it around 5:30 a.m. Goss credited firefighters from both cities for snuffing out flames under hazardous conditions; in charge for Farmington was Cmdr. Robert Schulz.

"When you have that much wind," Goss said, "the real trick is to get ahead of the fire. And it's really tough to do because the fire can actually jump over you."

Goss said firefighters went over to evacuate two homes on Violet, and "flames were literally coming across" in a northeasterly direction from the laundry facility. "We're fortunate that it didn't impinge on the houses."

Firefighters also couldn't get behind the burning buildings because of downed live electrical wires. Detroit Edison crews — because they were spread all

over the area to handle wind storm-related emergencies — did not make it to the fire scene until around 10 a.m., Goss said.

Also at the scene Wednesday morning was a crew from the Oakland County Sheriff Department's Fire Investigation Unit. But both Goss and Farmington City Manager Frank Lauffoff called it routine procedure for a fire of such magnitude.

There was only one reported injury, a wrist injury sustained by Farmington Officer Duane Cowger. He was treated and released from Botsford Hospital.

Goss said the Wash Hut sus-

tained about \$245,000 in damages (building and contents) and the Hong Kong restaurant about \$200,000 — not including the amount it will cost to replace the businesses. There was damage to about 50 percent of the restaurant.

Under normal weather conditions, firefighters would have had a better chance to contain flames to the laundry facility, he said.

Another factor was the proximity of the two businesses, which Goss estimated at less than 24 inches.
