# Acts of others leave us cold and snow bound

er, the big snow hasn't been without incidents.

On Doc. 18 Farmington was forced to ticket two dozen businesses for failure to clear snow from sidewalks. They had issued warnings and allowed them a week to comply. It seems to us that the businesses would have been better served if they had cleared the snow immediately.

The legal liability alone would prompt most reasonable people to act promptly. The city wisely requires snow removal from business owners' sidewalks for the safety of others.

We have written twice in our news columns about the problems at the sled hill on school-owned property on the northeast corner of Shiawassee and Farmington roads.

Kevin Gushman, from the City of Farmington's public services department, said the recent damage to the hay bales amounted to vandalism. Farmington Hills naturalist Joe Darek says the hill is being 'trashed.'

Some supervisory help, provided by the Farmington Hills Special Services recreation division, is on hand on weekends and on days when schools are closed.

Thus it's one of the great examples of the two cites and the schools cooperating on a useful project.

We urge everyone to atep up the self-regulation and to report acts of vandalism, such as the recent fire in some of the hay bales.

Rules include no snowboarding (there are other designated areas), no skiing and no tobogganing. Use designated return paths as a courtesy to others and don't sled toward unprotected Shi-

awassee.

It appears some Farmington and Farmington Hills homeowners were virinized by a local snow removal company. A handout in a mailbox prompted many of them to send money to the company but when the big blizzard came in December no snow removal services were provided.

It remains to be seen if the company will provide snow removal during the coming weeks. Hills police officials said that individuals would have to take the

company to small claims court or file a civil suit.

It seems to us that, if enough people didn't get promised snow removal, then the Onkland County prosecutor's office might want to look at the question of consumer fraud.

■ Finally, we have had two disturbing cases of parents loaving kids in cars unattonded. In one, the baby was only 18 months old. In another, a woman left her two kids in her car while she went to work. Fortunately, in both cases, other, more responsible, adults reported it to the authorities.
