Drug busts on our doorstep prove you can't hide problem

In the twisted, profit-driven world of drug running, appearances can be

In the twisted, profit-driven world of drug running, appearances can be deceiving.

The houses on Nine Mile Road and on Highmeedow in Farmington Hills don't look like the boarded-up, burned-out dens of iniquity commonly portrayed as the headquartors for narcetize dealers in the Big City.

But make no mistake – police took thousands of dollars in marijuana and heroin and weapons and cash from these locations.

How does this happen in our quiet suburban community? The truth is, the war against drugs has been waged all around us for decades. As the front lines grow increasingly difficult to hold, drug dealers have begun to retreat, putting communities like ours in the midst of the fray.

Hills Police Chief Bill Dwyer has said dealers hope to avoid detection by hiding in affluent homes, in quiet neighborhoods where people mostly keep to themselves and large amounts of cash can be spent on fancy cars, mink coats and ATVs without attracting any attention at all.

They've just picked the wrong time to settle in Farmington Hills – or anywhere in Oakland County, for that matter, Hills Police have initiated even stronger alliances with Oakland County's Narcotice Enforcement Team, newly canstituted under the direction of Sheriff Michael Bouchard and with the federal Drug Enforcement Administration.

squads, and a sheriffe deputy serves with the South Oakland Narcotics Information Consortium, which also includes officers from the Hills, West Bloomfield and Novi. If the currency of drug enforcement is information, police have hit the jackpot lately. Dwyer attributes that to the staffing exchange and an increased

focus on tracking major dealers.

"You have to try and hit at the highest level possible," Dwyer believes. "If you cut off the head, the body falls."

While the results speak for themselves three major drug busts in less than a month – it's been a little scary for Hills residents who may be wondering what lurks behind closed doors in their neighborhoods. Hard to think the teen-ager you see walking to the bus stop in the morning might be harboring bales of marijuana in his closet and aswed off shotgun underneath his bed.

The measure has been very controversial. Some people think it will dramatically increase the number of folks wandering around with permits to carry concealed weapons and, thus, the number of innocent people who are going to get shirt.

Now a group called People Who Care whout Kids Committee, headed by Attorney General Jennifer Granholm and Wayne County Prosecutor Mike Duggan, is circulating petitions to put the law to a referendum vote of the people. They need to submit more than 151,000 valid signatures of registered voters by March 27 to put the measure to a statewide vote, although they're siming for far more. There are good reasons to put this legislation to a vote. In fact, we urge interested readers to sign the petitions.

When the "shall issue" CCW legislation to take discretion to issue parmits out of the hands of local gun boards was criginally proposed, if provoked great public outery, in large part from the shooting incident at Columbine High School in Colorado. So our legislative isaders pulled the legislation back, hop-

If this wasn't enough, legislators dreamed up a little trick to try to make the legislation immune to referendum. Because the Constitution says appropriation bills are not subject to referendum, lawmakers tacked on \$1 million in spending in an attempt to block any petition drive. Sen. Phil Hoffman, R-Horton, and former Rep. Mike Green, R-Mayville, admitted that was the purpose of the allocation.

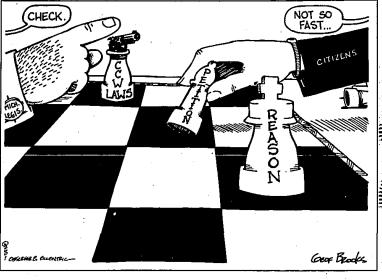
Sneaking important legislation through a lameduck sessions are intended to clean up legislative business that has been overtaken by an election, not to hide controversial legislation from public notice. But dreaming up a fancy simmick designed to prevent the public from considering the merits of legislation at referendum shows scant regard for the democratic process.

There will be plenty of time to debate whether the CCW legislation that lawmakers have passed is good or bad, but only if the drive to put the measure to statewide referendum succeeds. We urge readers to sign.

■ Gill parents speak

Farents and students of the year round program at Gill Elementary love the alternative schedule offered in the Farmington Public Schools. Our children are shining examples of success and public school achievement.

The students attend school the exact same number of days as kids on the traditional schedule.

In addition to the traditional vacations, year round students have two week inter-session breaks in November, February and May. Students attend approximately 10 weeks, then have a two week inter-session, and a six-week summer break.

We feel this is the best school schedule to reduce burnout. First grade year

We feel this is the best school schedule to reduce burnout. First grade year round teacher Clindy Shuster agrees.
"The year round schedule is much less stressful than the traditional schedule. Teachers, parents and students will all agree to that." Parent Kavin Mitchell agrees, stating "We've been in the program for eight years and have really enjoyed it. Our boys have never complained about having school in July."
Teacher Vickey Shaw, year round teacher for 8 12 years, adds, "Since wo longer need to schedule the school calendar around an agriculture year and since most children are ready to go back to school after five or six summer weeks off, it seems the year round calendar makes the most sense."
The main reasons we chose to place our students in the Gill Year Round program is they retain knowledge and have an easier transition to the next grade due to a shortened summer vecation. Our children still have a six week

grade due to a shortened summer vacation.

Our children still have a six week summer break, which is plenty of time to relax, take trips, and have fun. Third grade student Davud Kucukurslan says it works for him, "I like summer vacation because it's shorter and you don't forget stuff."

Another benefit of a year round schedule is the feeling of community with the year round families and staff. Students in Gill year round develop strong friendships, as they continue through each grade with the same students.

Parent Pam Prezioso, sees this as a real bonefit of year round, as 'the continuity for children and their friendships from year to year. This leads to less adjustment, as the whole class stays together. Parents also get to know one another and ner very supportive of year round education and dill Elementary Echol.

Timuergarien teacher Linda Lipson says 'I like the cohesive, small community feeling in the year round program. Since parents have specifically chosen this program for their children, they have demonstrated their commitment to being active partners in their children's education. It thin this is a definite strength of the program.

The jaws of life had to be used to remove the hadly injured woman. After making many contacts, I learned the new Gateway Mail offered to pay to put a light at their intersection.

I spoke with someone in the engineering department in Farmington Hills and they confirmed the above the arplained they couldn't put a light at that point because it was too close to Orchard Lake and the Pebble Greek complex; one quarter of a mile further west. They were unable to supply me with a record of the accidents that

west. Incy were unione to supply me with a record of the accidents that occurred without contacting the Bloomfield Police Department, as 14 Mile is shared by both cities. When I received their report, I noticed that 71.8 percent of the time the roads were dry when accidents took place. I was told they have plans to do something about this situation but it will take three years. There are a total of 12 exits and entrances onto 14 Mile with only two lanes and a "safe" center lane causing any cars winding up in the center to become head-on causalties. In the meantime, all these exits; Loehman Mall, Hunter Ridge Complex; Gateway Mall, and Gateway Apartments pose a real

serious threat to people driving in this
